Additionally I agree that:

In the event a traffic hazard or congestion develops on the public right-of-way associated with the permitted events, I will employ this City's police to control traffic and protect the public during such events.

I will provide, locate and maintain all traffic control devices (barricades, lights, signs, etc.) To identify the permit area during the permitted period per the above ordinances and Part IV of the Louisiana Department of Transportation and Development's "Manual on Uniform Control Devices" or the City of New Orleans Standard Plans.

All damages to the public right-of-way as a result of the construction will be rebuilt in accordance with this City's specifications within thirty (30) days at no cost to the City.

The City may require adjustments or removal of any or all equipment (materials, barricades, walkways, fencing, etc.) covered by this authorization to facilitate other projects or events within the street right-of-way.

No lifting operation which will block the moving lanes of traffic will be permitted between 7am and 9am or 4pm and 6pm weekdays.
